Requirements for Water Test Pass

Chapter 2: Regulations for AKC Hunting Tests for Pointing Breeds: ... "Shall be open to all pointing breeds six months of age or older on the first day of the event. The Water Test shall be judged by two approved field trial or hunting test judges. The dog shall retrieve a dead game bird or pigeon from the water after a swim of about 20 yards to the bird. A blank pistol shall be fired while the bird is in the air. The handler shall stand (6) six feet from the water and the dog may be restrained by holding its collar. The dog must demonstrate its willingness to enter the water, to swim, and to retrieve, at the direction of its handler without being touched or intimidated. The dog shall retrieve the bird to within two steps of the handler. The handler may give multiple commands. However, at some point the judges must conclude that the dog is unwilling to enter the water and the dog shall fail. Style shall not be considered. The dogs shall not be placed but shall either pass or fail.
