Fees for entries and any extras (meals, parking, etc.) include a Processing Fee. Entries and extras may be cancelled or changed online prior to the closing date, with refunds (less the Processing Fee per entry) available to keep as PerfDog credit, refund to credit card, or mail via check (less a \$3 Check Fee). Entries and extras may be cancelled online after the closing date, but no refunds will be given.

Once an entrant is drawn and braced, it may run as entered, move up to the next test level, or scratch without refund. Refunds (less the Processing Fee) will be granted only for bitches in season, injured or sick dogs (may require vet certification); or as deemed an emergency by the event committee. Entrants who complete a title during event #2024612704 may request advancement to the next level for event #2024612705 to the event secretary within 30 minutes of the test start.

Phone, fax or email entries will NOT be accepted.

Entries will close 6:00 pm (CST), Tuesday, October 22, 2024.

Drawing will take place at 6:30 pm (CST) October 22, 2024 at the secretary's home address.

Entries are limited to the number of dogs that can run during daylight hours and the test will close once that limit is reached.

Course

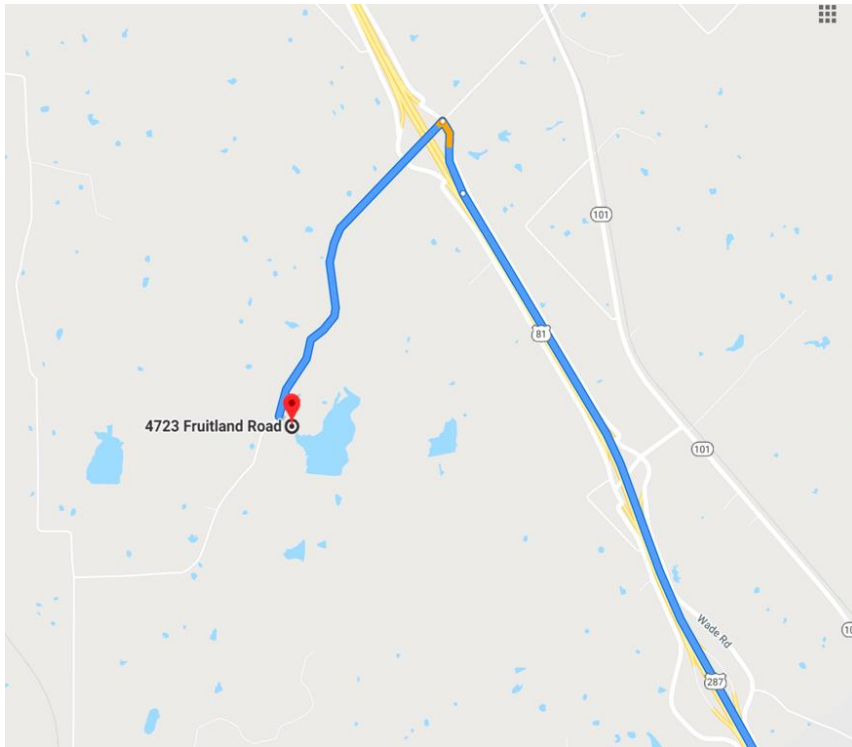
All tests are a single course without a bird field. Bobwhite quail will be used in all tests. Only blank pistols (starter pistol) may be used. All live shooting in master & senior tests will be done by official gunners. Handlers in the master test will be required to carry an unloaded shotgun or an "imitation" long---barreled gun. Handlers and gallery members in the master and senior braces will be required to wear blaze orange. NO horseback handling or gallery riders will be permitted.

DIRECTIONS TO ZYDECO RANCH

Master/Senior Course - From US-287/(81) (North or South): Take the Fruitland Road exit off of US-287 and go west onto the gravel road. Drive down Fruitland Road for approximately 2 miles and look for the black mail box on the left that says Zydeco. There are two driveways on the left next to each other. Take a left at the second entrance with the white fence. Signs will be posted.

Junior Course - Same directions as above, but go 0.5 miles further down Fruitland Road. Signs will be posted.
